We are working very hard to keep the market a fun and exciting place to be this season. We will be growing and developing a stronger relationship with our community. In order to be successful though, we need a firm commitment from you.

Our Mission is to have a Premium Farmers Market. The Board of Directors will accept and pursue applications from quality local or nearly local growers and producers. It is the Board's responsibility to determine which applicants to accept based on the Market Guidelines. Our goal is to limit nonagricultural vendors to 20% of the total stalls at each market. Every effort is made to search out quality growers of a variety of agricultural products.

If you are a new vendor, please find enclosed a copy of the Market Guidelines. Keep it for your information, and please sign and return the Acknowledgment to confirm that you have read and understand the Guidelines. The guidelines are posted on the market's website, www.amadorfarmersmarket.com and all vendors should be familiar with them. Certified growers should submit a copy of their county certification to the market manager as soon as possible. Please also submit an application to sell at the market and, if desired, for membership in the Association.

With a membership check of \$50 and regular attendance, you receive priority for your stall location at each market. The stall fees at each location are:

\$20 per market for members

\$30 per market for non-members

(The stall fee for Plymouth is \$20 for everyone.)

The deadline for submitting your application is May 1st. This deadline will help us to be well prepared for the start of the season, and more focused in our marketing efforts. Thank you for your compliance.

If you join the market and plan to attend weekly, please inform your Market Site Coordinator of any absences. If you have more than two unexcused absences, you may be replaced by another vendor at the Site Coordinator's and the Manager's discretion. Site Coordinators are the people who will assign you your market location and collect stall fees at the end of each market. The Site Coordinator is whom you call if you will be absent.
